- ii) Any other suitable technical inputs for betterment of the heritage domain.



3. Terms of reference and other conditions:


- i) The Tenure of the Committee would be two years from the date of notification.
- ii) The non-official members of the Committee will be eligible to travel by Air in economy class irrespective of their entitlement in their respective organizations, Boarding & Lodging as per GOI norms for attending the meetings of the Committee.


- iii) An honorarium of Rs.4000/- per day per non-official members will be provided for attending the meeting of the EAC.
- iv) The expenditure towards contingencies, such as Accommodation, Local Transportation, Stationery items and other incidental expenses will be borne by DST.
- v) The Committee could invite special invitees to advise on specific tasks as may be required.
- vi) The special invitees/co-opted members will also be entitled to travel by Air as per GOI rules and honorarium @ Rs.4000/- per day for attending the meeting of the Committee.
